

New ADA Laws

- All of our lifts are compliant with the New ADA Laws
- All swimming pools in the USA that fall under Title II or Title III need to comply with the new laws.

Title II (Public Industry) municipal pools, schools pools, government owned pools, etc.

Title III (Private Industry) place of recreation, place of lodging, which addresses public accommodations

- Existing pools shall become compliant with accessibility by March 15, 2012
- There are tax incentives available

242 Swimming Pools, Wading Pools and Spas

242.1 General – Swimming Pools, Wading Pools and Spas shall comply with 242

242.2 Swimming Pools

- At Least two accessible means of entry shall be provided for swimming pools with 300 linear feet or more.
- Accessibility means of entry shall be swimming pool lifts complying with 1009.2, at least one accessible means of entry shall comply with 1009.2 or 1009.3
- Sloped entries complying with 1009.3,
- Transfer Walls complying with 1009.4
- Transfer Systems complying with 1009.5

242.3 Wading Pools

- At Least one accessible means of entry shall be provided for wading pools
- Accessible means of entry shall comply with sloped entries complying with 1009.3

242.4 Spas

- At least one accessible means of entry shall be provided for spas.
- Accessible means of entry shall comply with swimming pool lifts complying with 1009.2
- Transfer walls complying with 1009.4
- Or transfer systems complying with 1009.5

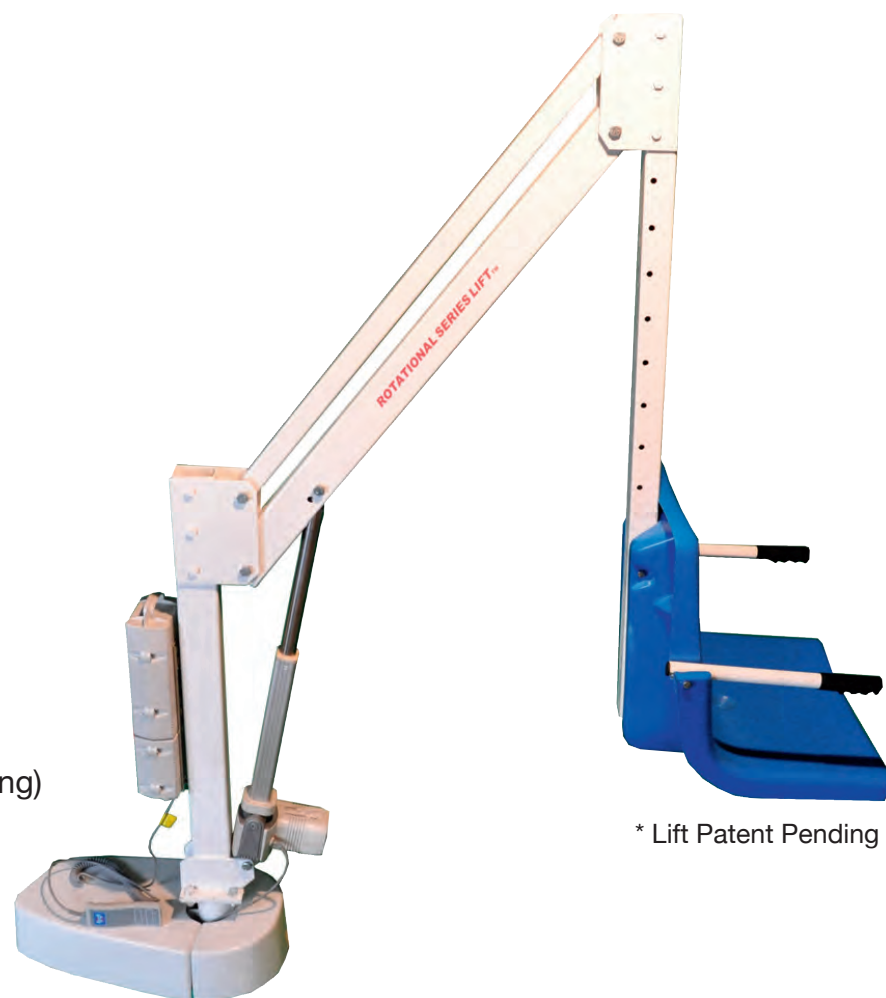
